



GEL 2011 GIOVANI ENERGIE LATENTI (Young latent energy)

Art.1

The Department of Youth and Community Politics in the Province of Ascoli Piceno, in cooperation with Eurodesk Italy, the information centers and youth centers, announces the 4 th edition of the "GEL - Young latent energy", open to all young people aged 16 to 30, living in one of the countries of the European Union.

The theme for this year is to be developed: "Young Europe Opportunities".

Art.2

The competition is free.

The competition is divided into two sections:

1. Very young children aged between 16 and 20 years;
2. Youth for boys aged between 21 and 30 years.

Art.3

The competition includes the following forms of expression:

- Photography
 - Comic
 - Painting / Illustration
- Participation is limited to one section.

Art.4

Participants will present the work together with the application, not later than **30 september 2011**. Failure to complete the required fields (marked with an asterisk) in the application form will be excluded from the competition.

The application form must be in the form attached and can be downloaded from the Province of Ascoli Piceno at [www.provincia.ap.it / polysoc](http://www.provincia.ap.it/polsoc).

For the date of shipment, the stamp of the post office.

Art.5

All the works must be unpublished.

The winning works will become property of the Province of Ascoli Piceno.

To pick up the work you must submit a request (the form will be available on line) and withdraw the work personally or by proxy, at the final event, the works have not been withdrawn at that time will become property of the Province.

The province can still use copy or representation of the works, even after they have been withdrawn, without any possible claims by the authors.

Art.6

Can be sent to participate in the competition:

the original works

the works on digital media (CD Rom - DVD).

The original work must also comply with the quantities specified below.

If the work it appears a winner in the category, the applicant must present and / or send the original work by the deadlines will be announced by the Province of Ascoli Piceno.

The Province is committed to giving reasonable notice to the competitor to allow the presentation or dissemination. The non-presentation of the work on time will result in exclusion from the competition and the loss of privileges reserved for the winner.

Art.7

Sizes for each category:

Photography

Photo and Digital Photography, for a maximum of three photos, which constitute a single work, in any medium and with any technique, with a maximum size of the total cm. 110 X 110, any captions shall not exceed 15 characters;

Comics

Tables made on A4 sheets, up to 4 tables or single table of maximum size 110 X 110;

Painting / drawing

Any technical support and with a maximum size cm. 110 X 110;

Art.8

Will be awarded a prize for the best dissertation of the two sections for each category.

The awards will be given in the competition web page.

There are no cash awards.

All participants will receive a certificate of participation.

The jury may award special mentions or not to award any prize in the categories of the competition at its sole discretion.

Art.9

During the period between the presentation of the works at the awards ceremony, the Provincial Administration, will hold one or more exhibitions of the works and / or publish on the website, without any remuneration to the authors.

Art.10

The Jury will be appointed by the province of experts in the various categories.

Art.11

The list of winners will be announced the day of the "Europe Day", where the ceremony will be conducted and published on the official site www.provincia.ap.it/polSOC/.

Winners must collect the prize in person or by delegating someone you trust.

Art.12

According to D. Legislative Decree No. 196/2003 "Protection of Individuals with regard to the processing of personal data " says that the processing of data of the participants in the competition is the only objective in the management of the competition.
